REPORT from LIBRARY STAFF:

Staff Day

RFPs

The library received only one response in each professional service category to our requests for proposal. Appointments will be formalized at the January 2018 reorganization meeting.

RESOLUTION 2017-43: Transfer of Funds

Ms. Boydston explained that some 2017 budget lines were in need of additional funds while other lines were underspent. Moving funds between lines does not change the overall budget. In particular, the health insurance line was about \$10,000 short because a payment deferral from several years ago had been carried forward until now. The health insurance payments are now current rather than a month behind. Also, funds were moved to the line for capital expenditures in anticipation of the parking lot improvement project.

RESOLUTION 2017-44: 2018 Budget

The proposed 2018 budget includes minor changes from 2017. Revenue is expected to increase slightly since the third of a mill library funding formula will be computed on higher equalized property valuation. Additional funding is requested for e-books and other digital resources. Another \$200,000 will be budgeted for capital expenditures.
